### The basis of resilience is a good social contract

- 1 Socio-political institutions are brittle when territorial control is lost.
- The most <u>resilient individuals</u> are self-reliant and do not have a default pro-government attitude.
- Societal resilience in the presence of foreign armed forces requires a force to unify resilient individuals.
- 4 A good social contract can be that force.
- A strategy of total defence can prepare for this, <u>but only if the threat is real and recognized</u>.

Both the <u>basis</u> and the <u>strategy</u> are needed.



### The basis of resilience is a good social contract



A whole-of-society effort: Society needs to be such that it is worth defending, even in the presence of foreign armed forces.



## When a good social contract is lacking, create or promise one.

Although the pilgrimage was made possible by the U.S.-led ouster of Saddam, some pilgrims marched with anti-American signs and called on the Americans to leave their country.




### A bit of theory



- 1 Thucydides: The strong do as they please and the weak suffer what they must.
- 2 Defeat can be a mechanism to preserve social cohesion under another regime.
- Throughout most of history, refusing defeat led to dull misery.
- Resilience in the presence of foreign armed forces became possible somewhere in the 19th century as a result of mass production of easy-to-use small arms.
- However, creating a successful strategy for <u>conflictual co-existence</u> is a challenge.



### A bit of theory: The franc-tireur

## Total Defence as a strategy: choose your level of skill and courage in the face of a real and recognized threat

- 1 Defence of strategic territory
- 2 Small unit tactics: raids and ambushes (12 WE) Behind enemy lines
- 3 Sabotage of supply lines (6 WE)
- 4 Providing information, logistic storage, safe houses
- 5 Medical care
- 6 Child care





### What would this look like for Belgium?

- 1 Presence of adversary foreign armed forces highly unlikely
- 2 Presence of allied foreign armed forces guaranteed (is also a stress to resilience).
- Focus total defence strategy on the enablement of the allied foreign armed forces.



### I In Sum

#### In sum

- Countries facing a real and recognized threat to their territorial integrity prepare for resilience in the presence of <u>adversary foreign armed forces</u>. The aim is to guarantee the restoration of constitutional order even after a prolonged foreign military presence.
- A good and solid social contract should be the basis for this resilience to <u>unify resilient</u> individuals after the collapse of national socio-political institutions.
- Countries not facing a real and recognized threat to their territorial integrity should focus their preparation efforts on the presence of <u>allied foreign armed forces</u> and on ways to enable them.
